Council comment on the DRAFT ORDER: Y&H/5329 PROPOSED STOPPING UP OF HIGHWAY AT HAWBER COTE LANE, BRUNTHWAITE, SILSDEN, BRADFORD, WEST YORKSHIRE BD20 0JJ We OBJECT to Order NATTRAN/Y&H/S247/5329 on the grounds that it is NOT necessary to Stop Up the subject Highway in order to enable the development to be carried out in accordance with the planning permission, should it be granted. It is quite clear from plan SIL-2021-001 Overall Site Layout rev P(5) that the holloway is NOT all. required for the development and so can remain. We will also be commenting on the planning application separately with a view to protecting this ancient feature. Moreover, the plan 22_01184_MAF-PROW_PROPOSALS-7029693 shows the subject Highway to be part of the route of the proposed perimeter walk AND part of the proposed new diversionary route of PROW no.45, as well as a new vehicular access into the development, therefore it is actually vital that it remains public highway.
