She further proposes that it is requested that this is omitted forthwith as it misrepresents the locality of Silsden which is a town in its own right, is nowhere near Bradford and eradicates the town's own identity.
13. Cllr Davis proposes that we ask the District Councillors report back on any progress on our request for HGV restrictions through Silsden
14. Cllr Davis proposes that we ask West Yorkshire Police to install police cctv cameras installed throughout Silsden for the purpose of monitoring crime within Silsden due to lack of cover by normal police patrols
